- 1/6/2010 First day to receive written applications for absentee ballots per C.R.S. 31-10-1002 (90 days)
- 1/21/2010 Written mail ballot plan submitted to and approved by City Council (75 days)
- 1/22/2010 Submission of Mail Ballot Plan to Secretary of State and Teller County Clerk and Recorder as per C.R.S. 1-7.5-105 (74 days – not later than 55 days) - no longer a requirement, but done as a courtesy
- 1/27/2010 Submit Notice 1 to PPCV for publication in 02/03/2010 edition - Charter Section 2.6
- 2/3/2010 Publish first notice of registration and election to the electorate as required by Charter Section 2.6 (62 days – done between 75 and 45 days)
- 2/5/2010 First day to circulate nominating petitions as required by Charter Section 2.10 (60 days)
- 2/9/2010 Last date for approval of Mail Ballot Plan by Secretary of State (56 days – 15 days after receipt by SOS) - CRS 1-7.5-106
- 2/19/2010 TABOR comments on ballot question due (done 45 days before) CRS 1-7-109 - 116
- 2/24/2010 Submit Notice 2 to PPCV for publication in 03/03/2010 edition (Charter Section 2.5 - 34 days - done between 45 and 20 days)
- 2/26/2010 Registration records ordered by designated election official from Teller County Clerk and Recorder (39 days)
- 3/3/2010 Publish second notice of election as required by Charter Section 2.5 (34 days – done between 45 and 20 days)
- 3/3/2010 Submit CRS Notice to PPCV for publication in 3/10/2010 edition - CRS 1-7.5-107 (2.5 a)
- 3/5/2010 List of electors submitted to City Clerk by the Teller County Clerk and Recorder (32 days) - CRS 1-7.5-102 a
- 3/7/2010 TABOR Notices to be mailed today - done 30 days before - Co. Const. Article X Section 20 3 b
- 3/8/2010 Close of voter registration (29 days)
- 3/10/2010 Publish notice of election required by CRS 1-7.5-107 (2.5 a) (27 days – not later than 20 days)
- 3/12/2010 Last day to circulate nominating petitions pursuant to Charter Section 2.1 of the (25 days)

3/19/2010 Ballots mailed (22 to 18 days) - CRS 1-7.5-107 3 a I

3/16/2010 First FCPA filing due - (21 days before election)

3/15/2010 Supplemental list of electors submitted to City Clerk by the Teller County Clerk and Recorder (20 days – not later than 20 days) - CRS 1-7.5-107

3/17/2010 Last day to appoint Elections Judges (15 days) 31-10-401

3/22/2010 Submit notice 3 to PPCV for publication in 04/07/2010 edition - Charter Section 2.5

3/24/2010 Verification of ballots begins (8 days – not sooner than 10 days) - CRS 1-7.5-107.5

3/29/2010 Notice 3 published in PPCV (not less than 5 days before election) - Charter Section 2.5
