BACKGROUND:

The attached report reflects the City's three percent sales tax revenue and lodging tax **received** July 2020 for **sales incurred** by taxpayers during the month of June 2020.


Sales Tax Collection compared to prior years




Lodging Tax Collection compared to prior years


